ON NOVEMBER 9, 2017, THE GATHERING RECEIVED A CALL ASKING OUR ORGANIZATION TO HELP PHILADELPHIA HIP HOP ARTIST MEEK MILL - WHO HAD THAT AFTERNOON BEEN SENTENCED TO 2-4 YEARS FOR A DISPUTED PROBATION VIOLATION ON A 10 YEAR OLD SENTENCE FROM WHEN THE RAPPER WAS A TEENAGER. WORKING WITH LOCAL AND NATIONAL ORGANIZATIONS, THE GATHERING ORGANIZED MASSIVE PROTESTS AND RALLIES AND PUBLIC RELATIONS/MEDIA EVENTS HIGHLIGHTING THE SYSTEMIC INJUSTICE SURROUNDING PROBATION, AND SUPPORTED HIS LEGAL TEAM WITH RESEARCH ON THE CRIMINAL JUSTICE IMPACTS OF HIS CASE AS IT RELATED TO WIDESPREAD ABUSE.
