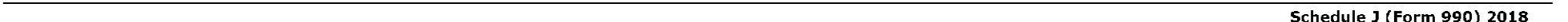

The Board annually evaluates the performance and the compensation of each Officer or Key Employee. The Board obtains comparable compensation information from outside the Organization and uses this information to determine the compensation package for each Officer or Key Employee. In setting compensation, the Board operates independently, without influence of the Organization's Officers. In the event that an Officer or Key Employee also serves as a Board member, the Officer or Key Employee refrains from the discussion and vote regarding compensation. |
