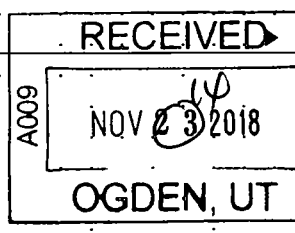

For example, we run childcare camps by collecting tuition and then distributing it to the childcare providers; in 2017 we supported enrichment activities by similarly collecting tuition and distributing it to enrichment providers. We also purchase school supplies on behalf of families, and pass through the fees to the vendor.

Part 1, line 10 "Grants and similar amounts paid " the organization pays grants to teachers to enrich student education, provides funds for activities for students such as Field Day and other classroom gatherings, and provides stipends for international teaching interns to enrich the multi-cultural education of students at the school (Described in more detail in Part III)
