Data & Knowledge Services GuideStar provides custom support to various stakeholders working to research and report on the nonprofit sector. In 2018, we published the 18th edition of our annual compensation report and assisted many organizations in their research. We provided data and analysis on several topics to a number of media organizations, including Bloomberg, CBS News, the Chronicle of Philanthropy, New York Times, Wall Street Journal, WBUR, and Birmingham, Dallas, Hartford, Houston, Portland, and Wichita Business Journals. Journalists incorporated this information into stories or used it as background to enhance the quality of their reporting on the nonprofit sector. GuideStar data served as the foundation for the Slate 90, published in May 2018, and an analysis of the impact of nonprofit transparency, published in the Journal of Accounting, Auditing & Finance in December 2018.

The GSPS applies to our GuideStar Nonprofit Profiles and determines an organization's qualifications for a Seal of Transparency. Nonprofits can earn Bronze, Silver, Gold, or Platinum Seals of Transparency depending on the amount of information they share. In 2018, GuideStar celebrated the second anniversary of the Platinum level of transparency which denotes nonprofits that share quantitative program results data. These organizations are empowered to tell their stories and explain their impact through programmatic metrics. Metrics can be drawn from the Common Results Catalog, the first sector-wide database of common programmatic metrics that GuideStar introduced in 2016. The catalog contains more than 755 common metrics applicable to different cause areas. As of December 31, 2018, GuideStar had 3.9 billion pieces of data, and more than 170,000 organizations had provided additional data for their GuideStar Nonprofit Profiles. Some 66,577 of these organizations had achieved the Bronze, Silver, Gold, or Platinum Seals.
