To provide a place in perpetuity where people with disabilities can be successful, equal and capable, growing to their maximum life's potential through interaction with horses in a positive environment. We accomplish our mission by providing recreational, educational, and sport programming, including vocational/pre-vocational opportunities, to youth at risk and persons with disabilities. Individuals are accepted without regard to race, religion, ethnicity, or socioeconomic background.

Teaching people with disabilities to ride and care for horses and preparing them to show at the Top Hands Horses Show and the Aldine ISD 2019 Livestock Show. In 2018, we taught 485 lessons to 66 riders with disabilities. A team of 26 riders participated in the 2018 Top Hands Horse Show (HLS&R) earning 5 first, 4 second, 6 third, 13 fourth, 12 fifth, 14 sixth, and 9 participation awards. Our why statement Living Life without Labels became the theme of our annual fundraiser. The year was challenged by notification of the end of our 17 year lease. Everyone pulled together and by years end we had a lease on 22 acres of land owned by the City of Houston and Bush Intercontinental Airport. Construction began on the new facility.

Providing adjudicated youth with the opportunity to serve their assigned community service hours - This included teaching them to use a garden rake and shovel to clean and repair the facility. Seven adjudicated youth completed 71 hours of community service, weeding our fence line, repairing our facility, and on special occasions helping with the horse program. Upon completion of their hours each has a better understanding of how to stay out of trouble. Success rate continues at 95% returning them to positive life pathways.

Utilizing volunteers to feed and care for our horses, instruct our people with disabilities, supervise adjudicated youth, maintain the facility, and complete all administrative and fundraising work - A total of 133 volunteers (including the adjudicated youths) gave 4,016 hours to operate Dream Catcher Stables program. This does NOT include administrative, fundraising, or site acquisition work. All board members participated actively providing 1,748 hours toward our cause. This year one of our former high school volunteers returned with her degree in speech therapy to become a permanent volunteer in our program. Her new goal is to obtain her M.S. and as part of her long term speech therapy practice provide needed services to Dream Catcher Athletes who need the service but are unable to afford it. Another volunteer, at her own expense attended a CHA Certification Clinic and now has her Level 2 English and Western credentials, thus enabling us in the future to extend program hours.
