Land Conservation GVLT furthered its mission to conserve working farms and ranches, wildlife habitat, and river corridors in the Gallatin Valley. We identify strategic areas with high conservation values and work to conserve blocks of open land that protect special parts of the valley. This year we conserved 574 acres of land in the Gooch Hill Area of Gallatin County with two local farming families and added 10 acres to an existing conservation easement in Big Sky. Our total conserved land is 46,400 acres in 104 conservation easements. Our staff develop long-term relationships with the landowners and visit each conservation easement annually to provide resources and monitoring to these properties. In FY18, we assisted 22 stewardship enhancement projects on the ground, worth a total of \$140,000 to enhance forest health, control noxious weeds, and plant streamside and wetland vegetation.

Form 990, Part III, Line 4b:

Community Trails - GVLTs Community Trails Program continued its mission to connect people, communities, and the land through collaborative trail projects. In 28 years, GVLT has helped create over 80 miles of trail. This year we secured the final necessary trail easement from the State of Montana to construct 1.5 miles of a trail connecting the Painted Hills Trail to the Triple Tree Trail. This completes the vision of GVLTs founder, a trail connecting Bozeman's Main Street to public land in the Gallatin Mountains. We also performed major deck and railing replacements on the three Gallagator Trail bridges, which see up to 800-1,000 users per day, supervised 30 volunteer work crews ranging in size from 2 to 275 people to perform trail maintenance, and coordinated the Trail Ambassador program with 10 partner organizations to outreach with over 750 trail users on proper trail etiquette.

Form 990, Part III, Line 4c:

Education GVLT communicates monthly with 15,000 supporters and shares current news on community trails, private land conservation, and related public events. GVLT makes its audited financial statements, annual report, and IRS Form 990 available on the website. GVLTs NextGen Advisory Board program cultivates the next generation with 21 young professionals who educate and inspire their peers to volunteer and support GVLT. In FY18 we utilized 1,327 volunteers to give 2,714 hours to the organization. All volunteers are educated about GVLTs mission and accomplishments during their service. The 36 free, guided Discovery Walks hosted 410 people to learn about GVLT, the community trail system, and local themes such as wildflowers, birds, history and more. The annual Summer Trails Challenge engaged nearly 2,000 community members to reach our goal of 66,000 miles of trail use for \$66,000 of support.
