ASMS served approximately 200 individuals through 700 adaptive ski and snowboard lessons. This season's client profile included six elementary, middle, and high school special needs classrooms involved in the 8-week Winter Sports School Program and the Bluebirds Special Olympics Ski and Snowboard Team. Also ASMS hosted special programs to serve veterans groups, rehab hospitals, community living centers, and specialized support networks. We had approximately 200 volunteers who donated approximately a collective 2,000 volunteer hours.
