Professional fees are for independent veterinarian care. House of Dreams is one of the few shelters that accepts cats without regard for age or medical condition. In addition, House of Dreams is one of the few shelters that accepts cats that test positive for the feline leukemia virus. In the current fiscal year we accepted 29 cats. Sixteen were from Multnomah County Animal Shelter or other shelters, and 13 were from previous/private owners. Some of these cats were feline leukemia positive. We adopted 19 kitties to loving homes during the current fiscal year. Expenses directly associated with the intake, care and adoption of these cats are as follows: Veterinary care and prescription food \$38,350; Litter and Food \$5,983; Medications \$5,287; Utilities \$6,401; Supplies \$1,357; Licenses \$285.
