The California Alliance for Arts Education is pleased to present a report on our major program accomplishments and highlights. During fiscal year 2018, the Alliance continued its Arts Now Campaign and Student Voices Campaign, supported our Arts Now Communities, empowered California school districts across the state to increase arts education through Local Control Funding Formula (LCFF) advocacy and the Arts Now Planning Initiative, and partnered with the California County Superintendents Educational Services Association (CCSESA) and the California Department of Education to strengthen the Title I policy pathway. We also worked with legislators and the Policy Council to advance arts education policy. The Alliance has made great strides in further developing the Arts Now Campaign. The Campaign supports the development of district and county arts plans through the Arts Now Planning Initiative, provides education about how districts can use arts strategies to improve outcomes for low income students through LCFF and the Title I program, empowers community members to advocate for arts education through Arts Now Communities, and promotes student voices in school decision-making and arts education advocacy. On December 8, 2017, the Alliance held the Arts Now Los Angeles County Arts Education Summit in partnership with the LA County Arts Education Collective, Arts for LA, and the LA County Arts Commission. The Summit marked 15 years of coordinated efforts for arts education in LA County. The event generated one media story and was attended by over 220 school board members, superintendents, district and school leaders, VAPA coordinators, teachers, arts leaders, community partners, students (grades 7-12) and community advocates. On April 7, 2018 the Alliance hosted the Arts Now Bay Area Summit in Oakland, CA. Our partners for this event included the Alameda County Office of Education, CCSESA, SFUSD, the Oakland Museum of California, and the California State PTA. As a result of our partnership with the Alameda County Office of Education, the Summit focused on local initiatives working to achieve educational equity in the arts. The Summit also featured a public forum for the candidates for the position of Superintendent of Public Instruction. Over 180 school board members, superintendents, district and school leaders, VAPA coordinators, teachers, arts leaders, community partners, students (grades 7-12) and community advocates attended the event and the event generated one media story. Arts Now Communities Throughout the 2017-2018 academic year, we have provided technical support, professional development and advocacy best practices to members of the Arts Now Communities. This training happens one-on-one between the field manager and local leader, as well as during group training sessions hosted by Alliance staff. We have empowered 24 Arts Now Community leaders to become effective arts education advocates. In addition to working individually with their assigned coach, leaders attended the 2018 Arts Now Leadership Institute held September 12 to 14 in Petaluma, California. The Leadership Institute featured presentations on how to assess equity in your local district, strategies for forging relationships and building a community coalition, and how to communicate effectively with stakeholders about arts education. This past year, we added 8 new Arts Now Communities to our network. We saw particularly impressive outcomes from our Arts Now Communities program for the 2017-2018 school year - 100% of Arts Now Communities developed a core leadership team that includes multiple stakeholders - 70% of local leaders spoke at a school board meeting - 95% of Arts Now Communities had arts education in their district's Local Control Accountability Plan - 35% of Arts Now Communities saw an increase in their districts' capacity to provide arts education as measured by the State of Arts Education Survey. Arts Now Planning Initiative Through our Arts Now Planning Initiative, we provided strategic assistance, high caliber facilitation, and financial support to help school districts and counties complete an arts plan. This spring, the Alliance completed five arts plans in collaboration with leadership in the following counties and district: Marin County, Mono County, Tulare County, Humboldt County, and Morgan Hill Unified School District. In addition, partnering with Create CA, Fresno County Superintendent of Schools and California County Superintendents Arts Initiative, the Alliance presented a workshop titled "Insider's Guide to Arts Education Planning." LCFF Materials We have refined and disseminated our Local Control Funding Formula (LCFF) advocacy materials and found new opportunities to share them with stakeholders, enabling them to deliver a clear, consistent, and compelling case for why arts education should be integrated into district wide distribution of local funding targeting high-needs students. The presence of advocates in local school districts is critical to helping ensure accountability on the implementation of the arts education strategies outlined in their Local Control and Accountability Plans (LCAPs). We have empowered and equipped representatives from a total of 29 school districts in California to do this work. 95% of sites in our Arts Now Communities program have arts in their district Local Control Accountability Plan. On February 14, 2018, we cosponsored an event with the Tulare County Office of Education and the California County Superintendents Arts Initiative called "Title I, LCFF, and the Arts: Funding Arts Education in California." This workshop for county and district administrators presented why and how arts education meets the eight state LCFF priorities, provided sample language for LCAPs, and shared best practices from the field for ensuring equitable access to the arts. Student Voices Campaign The 2018 Student Voices Campaign's culminating event took place at the Oakland Museum of California on April 7 and featured a video screening and awards ceremony. We received 59 student video submissions, each of which was sent to school board members in the student filmmaker's school district. A total of 28 teachers from around the state signed up to use the Teacher's Guide in their classrooms. Title I Initiative The Alliance participated in two workshops delivered by members of the Title I Arts cohort we launched in partnership with CCSESA. These 13 regional and district arts leads have committed over two years to helping us test the title1arts.org resources and promote and expand the use of arts strategies to achieve Title I goals. We have been able to work with ArtsEd New Jersey and the Perpich Center for Arts Education in Minnesota (a state agency) to develop sister versions of the title1arts.org website. Legislation During the spring legislative session, we worked to ensure that arts education is part of the conversation about increased funding for education in California. The Alliance worked closely with Senator Ben Allen, and sponsored his bill called the "Arts for Every Student Incentive Grant Program" (SB 933 Allen) which would establish a grant program to support arts education in California's most underserved school districts and student populations. We are pleased to share that the legislation has been adopted into the Governor's budget and will share \$44 million in federal Title IV funding for grants prioritizing visual and performing arts education, expanding access to physical and mental health care, and supporting school health centers. Policy Council Since 2010, the Policy Council has successfully grown into its role as a critical center for statewide policy conversations. We have approximately 40 organizations on the Council and we host two meetings per year rotating between Northern and Southern California which provide a diverse and engaging forum for leaders from education, business, arts, and parent organizations. Our first meeting of 2018 was held in Sacramento on February 1 and the second on June 21 in Los Angeles.
