LEARNING AND ENGAGEMENTS San Francisco Botanical Garden Society (SFBGS) maintains a library, offers year-round educational and community programming, and manages an extensive volunteer program. The Helen Crocker Russell Library of Horticulture is Northern California's most comprehensive horticultural collection and between July 1, 2017 and June 30, 2018, the library received 13,131 visits, a 28% increase over the prior year. During the same period, SFBGS hosted 12,942 children interacting with nature through school-year, summer and family programs. SFBGS also had 1,852 total volunteers - working individually or through corporate, school and service organization projects - who contributed 44,830 hours to virtually every aspect of the Garden's operations. Program revenue consists of ticketed community events, class and training fees, as well as books and art sold by the library.

PLANT COLLECTIONS, PROPAGATION AND GARDEN SUPPORTSFBGS funds garden improvements, provides curatorial and plant collections management services, and propagates thousands of plants annually, with many available for sale to the public. As of June 30, 2018, there were 13,964 accessions in the Garden's living collections, comprised of 8,958 different kinds of plants, 12% of which are of wild collected origin and represented by 1,458 taxa. Program revenue consists of plant sales.

VISITOR EXPERIENCE AND OUTREACH Between July 1, 2017 and June 30, 2018, the Garden welcomed 458,900 visitors - a 5.6% increase over the prior year and a 129% increase since 2010. SFBGS operates the Garden bookstore and gift shop and manages all community outreach efforts on behalf of the Garden. Program revenue consists of bookstore/gift shop sales and admissions income. Admissions income is comprised of reimbursed costs to operate the non-resident admissions program, as well as an allocation of the Garden's admissions receipts. Total admissions receipts in fiscal year 2018 were \$1,205,603, an 11% year over year increase, all of which is reinvested in the Garden.
