ADVOCACY, OUTREACH AND RESEARCH ACTIVITIES:-CONGRESSIONAL CONGENITAL HEART CAUCUS (39 MEMBERS TO DATE)-IN-DISTRICT ADVOCACY INITIATIVE: INCLUDED 100 CONSTITUENTS IN 25 STATES IN 2019-REGIONAL DEVELOPMENT LEADERS (COVERED THREE REGIONS IN 2019)-RESEARCH PROGRAM (IN 2019 ACHA FUNDED THREE, 1-YEAR FELLOW GRANTS AND YEAR ONE OF THREE, 2-YEAR FACULTY GRANTS) CONTINUED ON SCHEDULE O.CONGRESSIONAL CONGENITAL HEART CAUCUS: THE FORMATION OF THE CONGRESSIONAL CONGENITAL HEART CAUCUS IN 2012, INITIATED BY ACHA ADVOCACY EFFORTS, IS AN INFORMAL GROUP OF MEMBERS OF CONGRESS DEDICATED TO ISSUES RELATED TO CONGENITAL HEART DEFECTS. AT THE END OF 2019 THERE WERE 39 MEMBERS WHO WERE A PART OF THE CONGENITAL HEART CAUCUS.IN-DISTRICT ADVOCACY INITIATIVE: THIS NEW INITIATIVE OCCURRED FROM AUGUST 12-28, 2019. ACHA CONSTITUENTS WERE INSTRUCTED TO SCHEDULE MEETINGS WITH THEIR FEDERAL LEGISLATORS WHILE THEY WERE IN THEIR HOME OFFICES DURING THE AUGUST TIMEFRAME. WE WORKED WITH ABOUT 100 CONSTITUENTS FROM 25 DIFFERENT STATES TO OUTREACH TO THEIR LEGISLATORS TO DISCUSS ACCESS TO CARE, ABOUT ACHA AND LEGISLATIVE NEXT STEPS FOR THE ACHD PATIENTS.NATIONAL CONGENITAL HEART ADVOCACY DAY: MORE THAN 193 ADVOCATES FROM 30 STATES GATHERED IN WASHINGTON, D.C., ON MARCH 4-5, 2019 TO TALK TO THEIR LAWMAKERS CONGENITAL HEART DISEASE (CHD). HOSTED BY THE ADULT CONGENITAL HEART ASSOCIATION, CHILDREN'S HEART FOUNDATION AND THE PEDIATRIC CONGENITAL HEART ASSOCIATION, THIS ANNUAL EVENT BROUGHT TOGETHER PATIENTS, FAMILY MEMBERS, MEDICAL PROFESSIONALS, AND SUPPORTERS FROM ACROSS THE COUNTRY TO CONNECT WITH MORE THAN 143 LEGISLATIVE OFFICES.

EACH REGIONAL CONFERENCE BEGINS WITH A DYNAMIC PARTNERSHIP WITH LOCAL PATIENTS, PROFESSIONALS, AND INSTITUTIONS. THE EVENT IS TAILORED TO REGIONAL NEEDS AND CAN INCLUDE: AN EDUCATIONAL PRESENTATION (TOPICS INCLUDE ACHA 101, ACHD OVERVIEW, DEFECT SPECIFIC INFORMATION, ETC), GROUP ROUNDTABLE, AND EDUCATION MATERIALS AND RESOURCES.
