Activities & Governance	1 Briefly describe the organization’s mission or most significant activities: SILVER LINING MENTORING'S MISSION IS TO EMPOWER YOUTH IMPACTED BY FOSTER CARE TO FLOURISH THROUGH COMMITTED MENTORING RELATIONSHIPS AND THE DEVELOPMENT OF ESSENTIAL LIFE SKILLS. SILVER LINING MENTORING (SLM) IS THE ONLY MENTORING ORGANIZATION IN MASSACHUSETTS THAT EXCLUSIVELY SERVES YOUTH IN FOSTER CARE. THE YOUNG PEOPLE SERVED BY SLM HAVE BEEN REMOVED FROM THEIR HOMES DUE TO ABUSE AND/OR NEGLECT AND FACE FREQUENT CHANGES IN RESIDENTIAL PROGRAMS, SCHOOLS, COMMUNITIES AND CAREGIVERS. SLM'S VOLUNTEER MENTORS ARE OFTEN THE ONLY ADULTS IN FOSTER YOUTH'S LIVES WHO ARE NOT PAID TO SPEND TIME WITH THEM.SILVER LINING MENTORING SERVES YOUTH AGES 7 AND OLDER THROUGH MENTORS, A COMMUNITY BASED ONE-TO-ONE MENTORING PROGRAM AND THROUGH LEADERS, A LIFE-SKILLS PROGRAM FOR YOUNG PEOPLE AGES 14 AND OLDER WHO ARE PREPARING TO "AGE OUT" OF THE CHILD WELFARE SYSTEM. BOTH PROGRAMS ARE BACKED BY SILVER LINING'S TEAM OF CLINICALLY TRAINED, MASTERS LEVEL PROGRAM STAFF WHO HAVE POPULATION-SPECIFIC EXPERTISE.

IN 2019 SILVER LINING MENTORING (SLM) WAS PROUD TO HAVE SERVED 403 BOSTON AREA YOUTH THROUGH ONE-TO-ONE MENTORING RELATIONSHIPS, LIFE SKILLS DEVELOPMENT, COMMUNITY ACTIVITIES, AND SUPPORT FROM CLINICALLY-TRAINED SOCIAL WORKERS. THE FLAGSHIP COMMUNITY BASED MENTORING PROGRAM ONCE AGAIN EARNED ITS REPUTATION FOR PRECEDENT SETTING OUTCOMES AS SLM'S AVERAGE MENTOR-MENTEE MATCH LENGTH OF 55 MONTHS CONTINUED TO OUTPERFORM THE NATIONAL AVERAGE BY MORE THAN SIX TIMES. THE LEARN & EARN PROGRAM'S COHORT-BASED MODEL OF TEACHING LIFE SKILLS TO TEENS, RESULTED IN OVER 50% OF PARTICIPANTS OPTING TO EXTEND THEIR MENTORING RELATIONSHIPS AFTER GRADUATION. YOUNG ADULT SERVICES PROVIDED TEENS AND YOUNG ADULTS WITH CLINICAL SUPPORT AND RESOURCE BROKERING INCLUDING HOUSING SUPPORT, EMPLOYMENT ASSISTANCE AND FINANCIAL SUPPORT AS THEY TRANSITIONED OUT OF THE FOSTER CARE SYSTEM INTO INDEPENDENT ADULTHOOD.SILVER LINING MENTORING'S INVESTMENT IN PROGRAM QUALITY, EVALUATION AND DATA TRACKING HAS DELIVERED IMPRESSIVE RESULTS. A SAMPLE OF DATA OF SLM YOUNG PEOPLE OVER AGE 18 SHOWS THAT 76% OF SLM'S YOUNG ADULTS ARE EMPLOYED, COMPARED TO 43% OF FOSTER-CARE ALUMNI NATIONWIDE. IN ADDITION, WHEN COMPARED TO YOUNG ADULTS WHO HAVE EXITED FOSTER CARE NATIONALLY, 74% OF SILVER LINING MENTORING YOUTH HAVE GRADUATED FROM HIGH SCHOOL VS 54% NATIONALLY AND 23% OF SLM YOUNG PEOPLE HAVE ENROLLED IN COLLEGE COMPARED TO 3% NATIONALLY.IN THE FALL OF 2019, SILVER LINING MENTORING RECEIVED A HIGHLY COMPETITIVE MULTI-YEAR GRANT TO LAUNCH THE SILVER LINING INSTITUTE, A NATIONAL THOUGHT LEADERSHIP INITIATIVE, CREATED TO ENSURE THAT MORE YOUTH IN FOSTER CARE ACROSS THE UNITED STATES HAVE ACCESS TO HIGH QUALITY MENTORING. SILVER LINING RECEIVES MANY INQUIRIES FROM ORGANIZATIONS THROUGHOUT THE COUNTRY AND ACROSS THE GLOBE WHO WANT TO LEARN HOW TO EFFECTIVELY MENTOR AND SUPPORT YOUTH IN FOSTER CARE. THROUGH THE INSTITUTE, SILVER LINING WILL PROVIDE THESE ORGANIZATIONS TRAINING AND TECHNICAL ASSISTANCE AND SHARE POPULATION-SPECIFIC BEST PRACTICES TO ADVANCE THE FIELDS OF MENTORING AND CHILD WELFARE. ADDITIONALLY, THE SILVER LINING INSTITUTE WILL ENGAGE IN SYSTEMS REFORM AND BUILD PUBLIC AWARENESS TO EDUCATE STAKEHOLDERS AND LAY PEOPLE ABOUT THE CHALLENGES FACED BY YOUTH IN FOSTER CARE AND THE HIGH IMPACT, COST-EFFECTIVE SOLUTION THAT MENTORING PROVIDES. THROUGH A PUBLIC EDUCATION CAMPAIGN OVER THE COMING YEARS, THE INSTITUTE WILL PURSUE A PARADIGM SHIFT IN THE WAY COMMUNITIES AND INDIVIDUALS RESPOND TO YOUTH WHO HAVE EXPERIENCED TRAUMA AND FAMILY DISRUPTION. THE SILVER LINING INSTITUTE WILL CREATE A MOVEMENT OF ALLIES AND ADVOCATES WHO UNDERSTAND THE NEEDS OF YOUTH IN FOSTER CARE AND WILL STEP UP TO ENSURE THAT ALL YOUNG PEOPLE IN FOSTER CARE NATIONWIDE CAN BENEFIT FROM LONG-TERM MENTORING RELATIONSHIPS.
