In-School:During the 2018-2019 school year, we served 37 teachers and 2,637 students at 10 San Francisco Unified School District Schools through our In-School Program. For our 2019 Young Authors' Book Project, we released "We All Belong" with students at Galileo High School.

After-schoolOur After-School Tutoring Program at our Mission Center remains a cornerstone of 826 Valencia. During the 2018-2019 year, we launched a second After-School Tutoring program at our new Mission Bay Center. Both programs operate Mondays through Thursdays throughout the school year. During the 2018-19 school year, these programs served 220 enrolled students, with an average of 26 students each weekday. At our Mission Center, we also provide drop-in tutoring on Sundays. During the 2018-19 school year, 81 students participated in Drop-In Tutoring. Highlights of the year included our first-ever publication featuring work by our Sunday Drop-In students, our first book of student writing for our Mission Bay Center entitled, "A Magical Forest with Sparkles and Stars," and two issues of "Look Closer/Mira De Circa," a bilingual anthology of student writing from our Mission Center AST Program.










Field Trip Programs:During the 2018-2019 year, we hosted 223 field trips, serving a total of 4,90 students from local schools visiting our writing centers in San Francisco's Mission and Tenderloin Districts for a morning of high-energy learning. Our four-hour podcasting field trip, where students write personal narratives, short stories, and poetry and record them in our state-of-the-art recording booths, remains popular with middle and high school classes. Our two-hour "Storytelling and Bookmaking"--where students write, illustrate, and bind their own books--continues to be a perennial favorite for elementary schools.
