IN 2019, THE CNY CAT COALITION HAD ITS MOST SUCCESSFUL ADOPTION YEAR EVER, FINDING ADOPTIVE FAMILIES FOR NEARLY 800 HOMELESS CATS AND KITTENS. WE WERE ABLE TO ACCOMPLISH THIS THROUGH SEVERAL METHODS, INCLUDING ADDING A NUMBER OF NEW VOLUNTEER FOSTER HOMES TO OUR RANKS, AND INCREASING ADOPTIONS THROUGH OUR STORE ADOPTION CENTERS IN TWO PETSMART AND ONE PETCO STORES. WE HELD A RECORD-BREAKING FUNDRAISING CAMPAIGN IN DECEMBER THROUGH THE STAFFWORKS SAVE A LIFE FUND, RAISING MORE THAN 45,000 IN DIRECT DONATIONS FROM OUR SUPPORTERS, AND RECEIVING A MATCH OF 17,000 FROM THE STAFFWORKS FUND. THIS CAMPAIGN INCLUDED NEARLY 450 INDIVIDUAL DONORS OUR SPAY/NEUTER PROGRAM CONTINUED TO OFFER LOW-COST AND ATTAINABLE SURGERIES TO THOUSANDS OF LOW-INCOME CAT OWNERS WHO OTHERWISE WOULD NOT BE ABLE TO AFFORD TO HAVE THEIR PETS FIXED. OUR SPAY/NEUTER FIGURES INCLUDE NEARLY 2,200 CATS FIXING THESE ANIMALS PREVENTED THE BIRTH OF POTENTIALLY TENS OF THOUSANDS OF UNWANTED KITTENS. OUR RESCUE CATS AND PROGRAMS WERE FEATURED ON SEVERAL EPISODES OF OUR LOCAL NBC AFFILIATE, HELPING US EDUCATE THE PUBLIC ABOUT SPAY/NEUTER, ADOPTION, AND WHAT TO DO ABOUT STRAY ANIMALS IN THEIR NEIGHBORHOODS. WE HELD A SUCCESSFUL FUNDRAISING GARAGE SALE IN APRIL, BRINGING IN CLOSE TO 5,000 IN SALES. OUR BOOTH AT THE ANNUAL CANINE CARNIVAL HELPED US SPREAD OUR MESSAGE TO HUNDREDS OF PET OWNERS, INFORMING THEM ABOUT OUR PROGRAMS AND HOW THEY CAN BECOME AN ANIMAL RESCUER.
