NEW YORK CITY'S LARGEST COMMUNITY MUSIC SCHOOL, LUCY MOSES SCHOOL OFFERS PRIVATE INSTRUMENT LESSONS AS WELL AS CLASSES IN MUSIC, DANCE, AND THEATER TO STUDENTS OF ALL AGES FROM TODDLERS TO SENIORS AND ALL LEVELS OF EXPERIENCE. IN 2018-19, THE SCHOOL WELCOMED OVER 3,000 LEARNERS OF ALL AGES, ABILITIES, AND BACKGROUNDS WHO FOUND CLASSES AND TEACHERS THAT ENGAGED, EMPOWERED, AND INSPIRED THEM.

MERKIN HALL'S 2018-19 SEASON WAS EXCEPTIONAL. TUESDAY MATINEES, THE HALL'S LONGEST RUNNING SERIES, SHOWCASED RISING STARS LIKE VIOLINIST TESSA LARK AND THE ARGUS QUARTET. IN FEBRUARY, THE HALL DEBUTED A NEW CONCERT SERIES, ONLY AT MERKIN WITH TERRANCE MCKNIGHT, PROVIDING AUDIENCE MEMBERS WITH INSIGHTFUL CONVERSATIONS AND VIRTUOSIC PERFORMANCES BY ACCLAIMED PIANISTS URSULA OPPENS AND ANDRE WATTS AND HARPISIT BRIDGET KIBBEY. THE CENTER ALSO PRESENTED GROUNDBREAKING NEW WORKS AT THE NINTH SEASON OF ECSTATIC MUSIC: A SIX-CONCERT SERIES FEATURING ADVENTUROUS ARTIST COLLABORATIONS REPRESENTING A DIVERSE COLLECTION OF GENRES AND SOUNDS. IN A SERIES OF SOLD-OUT PERFORMANCES, BROADWAY CLOSE UP GAVE THEATER FANS A NEW PERSPECTIVE ON THE SHOWS AND SONGS THEY LOVE, PLUS A PREVIEW OF THE BEST NEW MUSICALS HEADED TO BROADWAY. BROADWAY PLAYHOUSE INTRODUCED CHILDREN FROM ACROSS NYC TO MUSICAL THEATER. IN JULY 2019, WE LAUNCHED THE INNOVATORS CIRCLE, A MEMBERSHIP GROUP FOR LEADERSHIP SUPPORTERS OF THE HALL. MEMBERS OF THE CIRCLE WILL ACCESS EXCLUSIVE BENEFITS DURING THE 2019-20 SEASON, INCLUDING AN INVITATION TO A PRIVATE CONCERT AND COCKTAIL RECEPTION WITH ROB KAPILOW, ATTENDANCE AT DRESS REHEARSALS FOR SOME OF OUR CELEBRATED CONCERT SERIES, AND SPECIAL RECOGNITION IN MERKIN HALL PROGRAMS.

SPECIAL MUSIC SCHOOL IS NYC'S ONLY K-12 PUBLIC SCHOOL THAT TEACHES MUSIC AS A CORE SUBJECT, AND THE SCHOOL REPRESENTS A UNIQUE PARTNERSHIP BETWEEN KAUFMAN MUSIC CENTER AND THE NYC DEPARTMENT OF EDUCATION. THE CENTER'S FUND FOR MUSIC EDUCATION FULLY FUNDS THE MUSIC PROGRAM, ALLOWING STUDENTS TO STUDY WITHOUT THE FINANCIAL BARRIERS ASSOCIATED WITH WORLD-CLASS MUSICAL EDUCATION. OUR GRADUATES ATTEND TOP COLLEGES AND CONSERVATORIES, INCLUDING THE JULLIARD SCHOOL, NEW ENGLAND CONSERVATORY, BARD COLLEGE AND CONSERVATORY, BERKLEE COLLEGE OF MUSIC, COLUMBIA UNIVERSITY, OBERLIN COLLEGE AND SMITH COLLEGE.









FACE THE MUSIC IS THE COUNTRY'S PREMIER YOUTH PROGRAM DEDICATED TO MUSIC BY LIVING COMPOSERS. STUDENTS HAD THE OPPORTUNITY TO STUDY WITH RENOWNED ARTISTS INCLUDING MISSY MAZZOLI, CLAIRE CHASE, HELGA DAVIS, MAZZ SWIFT, BROOKLYN RAGA MASSIVE AND THE INTERNATIONAL CONTEMPORARY ENSEMBLE. THE PROGRAM ALSO HOSTED A STRING QUARTET RESIDENCY PROGRAM WITH ETHEL AND PERFORMED WITH ROCK LEGEND TODD RUNDGREN AS PART OF ECSTATIC MUSIC IN MERKIN HALL. STUDENTS HAD OPPORTUNITIES TO APPEAR AT OTHER PRESTIGIOUS VENUES INCLUDING THE RUBIN MUSEUM, NATIONAL SAWDUST AND ROULETTE. SPECIAL PROJECTS AT KAUFMAN MUSIC CENTER ARE GENERALLY SHORT-TERM INITIATIVES THAT ARE FUNDED SEPARATELY TO PROMOTE THE CENTER'S MISSION. PROJECTS IN 2019 INCLUDED A RESIDENCY PROGRAM, CO-SPONSORED BY THE JOHNNY MERCER FOUNDATION, THROUGH WHICH TEACHING ARTISTS FROM KAUFMAN MUSIC CENTER VISIT THIRD AND FOURTH GRADE CLASSROOMS IN NEW YORK CITY PUBLIC SCHOOLS, GIVING THEM THE SKILLS AND BACKGROUND THEY NEED TO WRITE THEIR OWN LYRICS. IN 2019, ONCE AGAIN, KAUFMAN MUSIC CENTER RAN THE LUNA COMPOSITION LAB WITH ACCLAIMED COMPOSERS MISSY MAZZOLI AND ELLEN REID. LUNA COMPOSITION LAB IS A MENTORSHIP PROGRAM THAT ADDRESSES THE GENDER GAP IN CLASSICAL MUSIC BY PROVIDING MENTORSHIP AND INSTRUCTION FOR YOUNG FEMALE-IDENTIFYING COMPOSERS. THE BIRNBAUM MUSIC LIBRARY SERVES THE DIVERSE POPULATIONS OF KAUFMAN MUSIC CENTER. WITH ITS COMPREHENSIVE COLLECTION OF ISRAELI MUSIC AND TAPES, THE LIBRARY IS AVAILABLE TO COMPOSERS AND PERFORMERS ALIKE. FACULTY AND STUDENTS OF BOTH KAUFMAN MUSIC CENTER SCHOOLS CAN FIND REPERTOIRE THEY NEED TO TEACH AND PERFORM.
