POWERS AND AUTHORITY: THE EXECUTIVE COMMITTEE SHALL HAVE ALL OF THE AUTHORITY OF THE BOARD OF DIRECTORS DURING THE PERIODS BETWEEN MEETINGS OF THE BOARD OF DIRECTORS, EXCEPT: (A) WHERE SUCH ACTION IS PROHIBITED BY LAW OR THESE BYLAWS; (B) WHERE SUCH ACTION IS PROHIBITED BY THE ARTICLES OF INCORPORATION; (C) THE POWER TO AMEND OR REPEAL THESE BYLAWS; (D) THE POWER TO AMEND OR REPEAL AN ACTION TAKEN BY THE BOARD; (E) THE POWER TO SET COMPENSATION FOR THE EXECUTIVE STAFF; (F) THE POWER TO ELECT OR REMOVE DIRECTORS, OFFICERS, TRUSTEES, THE EXECUTIVE DIRECTOR OR THE CHIEF OPERATING OFFICER; (G) THE POWER TO ADOPT A PLAN OF MERGER; AND (H) THE POWER TO AUTHORIZE THE VOLUNTARY DISSOLUTION OF THE CORPORATION. THE EXECUTIVE COMMITTEE SHALL: (A) MONITOR THE CENTER'S COMPLIANCE WITH ITS LEGAL OBLIGATIONS; (B) ACT AS THE LEGAL REPRESENTATIVE OF THE BOARD DURING EMERGENCIES; (C) SERVE AS THE PRIMARY SUPPORT MECHANISM FOR THE EXECUTIVE STAFF DURING NORMAL BUSINESS AND TIMES OF CRISIS; (D) IN COLLABORATION WITH THE GOVERNANCE AND NOMINATING COMMITTEE, REVIEW EACH DIRECTOR'S ACTIVITY, PARTICIPATION, AND FULFILLMENT OF RESPONSIBILITIES; (E) RECOMMEND NEW DIRECTORS TO THE GOVERNANCE AND NOMINATING COMMITTEE; AND (F) CREATE NON-STANDING COMMITTEES AND TASK FORCES AS NECESSARY. ANY ACTION BY THE EXECUTIVE COMMITTEE SHALL BE REPORTED IN WRITING TO THE BOARD WITHIN SEVEN (7) DAYS OF SAID ACTION AND SHALL BE SUBJECT TO APPROVAL, REVISION, OR DISAPPROVAL BY THE BOARD, PROVIDED THAT NO SUCH RECONSIDERATION SHALL ADVERSELY AFFECT THE RIGHTS OF THIRD PARTIES WHO HAVE ACTED IN RELIANCE ON THE ACTION OF THE EXECUTIVE COMMITTEE TAKEN IN ACCORDANCE WITH THE AUTHORITY OF THESE BYLAWS.
