Community Based Services under this category directly support youth throughout their incarceration and transition to the community by helping them set and achieve goals to improve their civic and community engagement and to develop positive, healthy ties to their families and broader communities that allow them to contribute to society in meaningful ways. This category encompasses a broad range of Friends program offerings, including but not limited to Friends to Fathers (discussed below), the Youth Reentry Network, and the Makeba Project. Friends to Fathers is a Bronx-based program that seeks to break intergenerational cycles of incarceration by working with noncustodial fathers to increase their engagement and involvement with their children, improve parenting skills, address domestic violence, build cognitive/behavioral skills, and facilitate gainful employment. From July 1, 2018 to June 30, 2019, the Friends to Fathers program enrolled 218 fathers and achieved 378 positive outcomes. Specifically, 120 fathers attained needed benefits and services, 129 fathers increased engagement, availability, and responsibility in their relationships with their children, and 129 participants increased material and financial support of their children.

Form 990, Part III, Line 4b:

Health and Well-Being Services under this category directly support youth throughout their incarceration and transition to the community by helping them set and achieve goals to improve their overall health and well-being, and by supporting them to navigate barriers to positive social inclusion that would otherwise increase their likelihood of recidivism. This category encompasses a broad range of Friends program offerings, including but not limited to the Youth Reentry Network (discussed below), Arches, and the Makeba Project. The Youth Reentry Network is Friends' system of pre and post-release transitional supports and services for young people held on Rikers Island and the Horizon Juvenile Center. Friends Youth Advocates forge relationships with young people while they are in jail, then sustain and develop these connections following their release into the community by providing an array of neighborhood-based supports and services, as well as sustained advocacy, mentorship, and a sense of community. Youth Advocates support youth to set and achieve goals around five key program domains: education, employability and employment, health and well-being, civic engagement, and recreation and the arts. From July 1, 2018, to June 30, 2019, Friends Youth Advocates and Mitigation Specialists engaged and enrolled 738 youth at Rikers Island and the Horizon Juvenile Center. Close to 57% voluntarily engaged with their advocates post-release in the community, implementing the youth plans they developed together while in custody.

Form 990, Part III, Line 4c:

Employment Employability and employment opportunities provide formerly incarcerated youth with critical pathways to economic independence, as well as a sense of purpose and self-worth. Friends Career Services Center prepares young people for work and provides achievable career pathways to support long term economic independence among the youngest people released from jail in New York City. Youth members participate in a paid five-day training program and are then connected to opportunities for paid internships and job placement. From July 1, 2018 to June 30, 2019, the Career Services Center engaged 175 youth, enrolled 120 youth in the paid five-day training program, placed 69 youth in paid internships (subsidized employment), and placed 37 youth in permanent unsubsidized employment.
