NICA operated associated leagues in Northern California, Southern California, Colorado, Utah, Minnesota, Tennessee, Texas, New York, Arizona, Georgia, Alabama, Virginia, Idaho, Pennsylvania, Nevada, Arkansas, New Jersey, North Carolina, Oregon, Maryland, West Virginia, Montana, Indiana, South Carolina, Wisconsin, Florida, and Missouri and with development stage leagues for future years with formative strategies in other states. League materials and methods are refined each year, in order that we create the national standard of best practice in the areas of safety, supervision, adventure, and youth cycling development.
