Bihl Haus Arts (BHA) is a community-based nonprofit organization founded in 2005. Located on the premises of Primrose at Monticello Park Senior Apartments, on historic Fredericksburg Road in San Antonio, Texas, it is likely the only professional gallery for contemporary art in the United States on the premises of 100% affordable senior housing. BHA expresses its mission to XCreate Community through the Arts" in three focus areas: 1. BIHL HAUS ARTS GALLERY EXHIBITIONS stimulate creative use of exhibit space and set a high standard for local/national/international artists to network, display and sell their work. The Gallery both a site for senior resident activities and a professional public contemporary art exhibition space demonstrate an innovative model of public/private partnership built with funding from the Primrose at Monticello Park Senior Apartments and recognized by the San Antonio Historical Society for innovative reuse of a historic building, a model for public/private partnership

BHA consciously engages in creative placemaking that highlights connections between visual and performing artists and area neighborhoods, and environmental conditions within which creation occurs; nurtures, employs and creates awareness of the work of exceptional local visual and cultural artists; fosters an inter-generational and multicultural learning community among established and emerging artists, older adult and veteran participants and the public; and maximizes access to collective resources through collaboration and partnerships with other nonprofit and for-profit arts and social service organizations. Through diverse programming, BHA tells the stories, explores the ideas, and shares the words that help us make sense of our lives and our world. BHA embraces an array

BHA is perhaps the only non-profit professional art gallery on the premises of 100% senior affordable housing in the United States. The gallery occupies a renovated historic building at Primrose at Monticello Park Senior Apartments. BHA serves diverse economically disadvantaged populations in underserved neighborhoods targeted by the City for revitalization. BHA is staffed by the 20-member volunteer Docent Committee, many of whom reside at Primrose. Most events are conducted in the gallery, which also serves as a classroom for GO! Arts, which celebrated it's 10th anniversary in fall 2017. BHA, which celebrated its 10 anniversary in fall 2015, has produced nonstop, diverse, critically acclaimed cultural programming developed with input from local arts experts and enriched by community collaborations. BHA began receiving ongoing operating support from the City of San Antonio's Department for Culture and Creative Development in 2013 and from the Texas Commission on the Arts in 2015. Local support has also come from the Kronkosky, Shield-Ayres, and WellMed Charitable Foundations, among others.











