WE DO THIS BY FACILITATING AND PROMOTING SPAY/NEUTER OF OWNED CATS AND TRAP, NEUTER, AND RETURN (TNR), FOSTER-BASED RESCUE AND ADOPTION FROM LOCAL SHELTERS, AND PET RETENTION AND REHOMING PROGRAMS. OUR INTENT IS TO STEADILY DECREASE THE INTAKE OF CATS AND KITTENS AT LOCAL SHELTERS AND TO ULTIMATELY END THE EUTHANASIA OF HEALTHY ADOPTABLE PETS IN THE COMMUNITIES WE SERVE.

ALL CATS WERE ALTERED, TESTED, VACCINATED AND TREATED FOR PARASITES PRIOR TO ADOPTION. MANY OF THESE CATS CAME TO US INJURED OR ILL REQUIRING ADDITIONAL VETTING EXPENDITURES TO READY FOR ADOPTION. CATS WERE TAKEN IN FROM AREA ORGANIZATIONS, SUCH AS PAGE COUNTY ANIMAL SHELTER IN PAGE COUNTY, VA., AND THE SHENANDOAH VALLEY ANIMAL SERVICES CENTER IN AUGUSTA CO., VA. IN ADDITION 191 CATS WERE TRANSPORTED FOR ADOPTION TO VARIOUS LOCATIONS OF OUR NO-KILL SHELTER PARTNER, THE BRANDYWINE VALLEY SPCA IN PENNSYLVANIA. CONTRIBUTED VETERINARY SERVICES IN THE FORM OF DISCOUNTS TOTALED 10,883.02.
