IN FY19, FPS ASSISTED 256 PATIENTS AND PROVIDED RESPITE EXPERIENCES TO 154 FAMILIES. FPS OFFERS YOUNG ADULT CANCER PATIENTS AGES 24 TO 50, AND THEIR FAMILIES A RETREAT FROM THE UNYIELDING PHYSICAL AND EMOTIONAL DEMANDS OF CANCER BY PROVIDING EXPENSE PAID RESPITE VACATIONS TO ADDRESS THE PSYCHOLOGICAL, EMOTIONAL, ECONOMIC AND SPIRITUAL TRAUMA ASSOCIATED WITH A CANCER DIAGNOSIS. TO BE ELIGIBLE FOR THE PROGRAM, A PATIENT MUST BE NOMINATED BY A MEMBER OF HIS/HER ONCOLOGY TEAM. FPS NOMINATORS USE CLINICAL ASSESSMENT FACTORS TO BEST IDENTIFY PATIENTS IN NEED OF RESPITE. NEW NOMINATORS PARTICIPATE IN A SHORT EDUCATIONAL PROGRAM ABOUT THE MISSION OF FPS. SOME NOMINATORS SERVE AS MEMBERS OF THE FPS PROGRAM ADVISORY COMMITTEE, CHARGED WITH OVERSEEING THE ENTIRE PATIENT PROGRAM, PROGRAM GUIDELINES, AND CLINICAL ASSESSMENT FACTORS. OUR TOP THREE NOMINATING MEDICAL INSTITUTIONS INCLUDE CROZER CHESTER MEDICAL CENTER, PENN ABRAMSON CANCER CENTER AND MD ANDERSON CANCER CENTER.

EVALUATION OF THE PROGRAM IS ASSESSED IN PART FROM STATISTICS DERIVED FROM PATIENTS' EVALUATIONS EVALUATION BY NOMINATING ONCOLOGISTS. SINCE MEASUREMENT BEGAN, THE OVERALL RATING OF THE IMPROVED ABILITY TO COPE WITH CANCER IS 3.91 ON A SCALE OF ONE TO FOUR. IN AN EFFORT TO REMAIN TRANSPARENT, FPS POSTS ITS PATIENT AND NOMINATOR OUTCOME MEASURES ON ITS WEBSITE. ONE HUNDRED PERCENT OF ALL NOMINATING PROFESSIONALS RECOGNIZE POST-RESPITE IMPROVEMENT IN THE PATIENTS AND PATIENT'S FAMILY/CAREGIVER'S ABILITY TO COPE WITH CANCER. FPS ALSO BEGAN A RESEARCH STUDY TO CORRELATE THE SIGNIFICANCE OF RESPITE WITH IMPROVED OUTCOMES RELATED TO COMMUNICATION, TREATMENT, MENTAL HEALTH, RELATIONSHIPS (BOTH WITHIN FAMILY AND TREATMENT TEAM) AND OTHER GENERALIZED DAILY ACTIVITIES.

IN FY19, FPS RECEIVED TWO LARGE DONATIONS TOTALING 850,000, WHICH THE FPS BOARD DESIGNATED A PORTION FOR ENDOWMENT AND OTHER PURPOSES. THESE FUNDS ARE INVESTED FOR LONG-TERM APPRECIATION AND A RESOURCE TO BE USED FOR SUSTAINABILITY AND GROWTH. FPS USES DONATED VACATION HOMES AND RESORTS FOR RESPITE VACATIONS. IN FY19, FPS RECEIVED ALMOST 550,000 OF IN-KIND SUPPORT FOR THE PROGRAM IN THE FORM OF COMPLIMENTARY OFFICE SPACE, PATIENT ACCOMMODATIONS, PROFESSIONAL AND MARKETING SERVICES, RESPITE SUPPLIES AND SPECIAL EVENT GOODS AND SERVICES. IN ADDITION TO CONTINUING THE STAYCATION PROGRAM, AIMED AT PROVIDING AN "IN HOME" RESPITE EXPERIENCE FOR PATIENTS TOO SICK TO TRAVEL, FPS WAS ABLE TO PROVIDE AN INCREASED LEVEL OF ANCILLARY SERVICES TO ITS PATIENTS THROUGH THE PROCUREMENT OF SEVERAL GRANTS AND IN-KIND GIFTS. THE SERVICES INCLUDED, BUT NOT LIMITED TO, ADDITIONAL SUPPORT FOR OUR PATIENTS THROUGH COMPLIMENTARY TICKETS TO AMUSEMENT PARKS AND ATHLETIC EVENTS, MONTHLY LUNCH BUNCH, ASSISTANCE DURING THE HOLIDAY SEASON, AND CONTINUED WEEKLY OUTREACH RUN BY VOLUNTEERS. PANO CERTIFICATION: FPS IS A PROUD RECIPIENT OF THE PENNSYLVANIA ASSOCIATION OF NONPROFIT ORGANIZATIONS (PANO) STANDARDS FOR EXCELLENCE CERTIFICATION. THIS AWARD RECOGNIZES FPS AS AN ETHICAL AND ACCOUNTABLE ORGANIZATION DEDICATED TO THE HIGHEST LEVEL OF EXCELLENCE WITHIN THE NONPROFIT SECTOR. THIS AWARD IS BESTOWED ONLY TO THE MOST WELL-MANAGED AND RESPONSIBLY GOVERNED NONPROFIT ORGANIZATIONS THAT HAVE DEMONSTRATED COMPLIANCE WITH THE 56 SPECIFIC STANDARDS FOR EXCELLENCE BASED ON HONESTY. FPS IS ONE OF 50 NONPROFITS STATEWIDE AND THE FIRST NONPROFIT IN MONTGOMERY COUNTY TO HOLD THIS HONOR FROM OVER 11,000 REGISTERED PA CHARITIES. FPS HAS MET, COMPLIED WITH, AND INTEGRATED THE CERTIFICATION PROGRAM AND THUS, ALL GOVERNANCE QUESTIONS ASKED IN THE FORM 990 HAVE BEEN ADDRESSED BY THE ORGANIZATION IN ITS NORMAL COURSE OF BUSINESS. ADVANCEMENT: FPS HOSTS SEVERAL SPECIAL EVENTS, INCLUDING A WALK AT CITIZENS BANK PARK IN PHILADELPHIA. THESE EVENTS PROVIDE ABOUT 20% OF THE ORGANIZATIONS INCOME. ADDITIONALLY, FPS SUPPORTERS HOST COMMUNITY FUNDRAISING EVENTS, INCLUDING 5K RUNS, FLIP FLOP FRIDAYS AND CORPORATE AND SCHOOL DRESS DOWN DAYS. FPS IS FUNDED 100% BY DONATIONS FROM PRIVATE INDIVIDUALS, PRIVATE FOUNDATIONS, CORPORATIONS AND COMMUNITY SUPPORT. SUSTAINABILITY AND GROWTH: A PART OF THE FY19, LARGE DONATIONS WERE USED TO FUND GROWTH AT FPS. PART OF THAT GROWTH WAS FUNDING A NEW YORK TERRITORY OFFICE WITH TWO STAFF MEMBERS. THE FUNDS WERE USED TO FOSTER GROWTH AND SUSTAINABILITY AT FPS AS SEEN IN THE INCREASE IN PROGRAM EXPENSE FROM PRIOR YEAR. INCLUDED IN THE INCREASE WERE THREE COMMUNITY GROUP RESPITES AND 15 STAYCATIONS.
