The 2019 five-day/four night camp sessions took place in two locations near Atlanta, Georgia (Camp Twin Lakes in Rutledge, GA) and in Western North Carolina (YMCA Camp Harrison in Boomer, NC). Camps were leased for one-week programs in March and October. The website is maintained for camper sign-up and for recruitment of volunteers. There is extensive planning for camp sessions for adults with developmental disabilities. The Williams syndrome camp session was held March 11-15, 2019 and served 55 adults with Williams syndrome with help from 48 volunteers. A second camp session in Georgia was held March 18-22, 2019 and served 65 disabled adults with help from 71 volunteers. The first North Carolina session was held October 5-9, 2019 and served 60 disabled adults with help from 59 volunteers. The second NC session was held October 12-16, 2019 and served 62 disabled adults with help from 66 volunteers. A third camp option was added in 2019—a weekend camp (3 day/2 night session) that took place in upstate South Carolina (YMCA Camp Thunderbird in Lake Wylie, SC). The weekend camp was held December 6-8, 2019 and served 47 disabled adults with help from 67 volunteers.
