THEY FIND SOLACE, PROTECTION, AND COMPANIONSHIP THROUGH THEIR PETS. THEY CARE FOR THEIR PETS ON LIMITED RESOURCES SO THEY THEMSELVES HAVE LESS. OUR TASK, NATIONWIDE, IS TO FEED AND PROVIDE BASIC EMERGENCY VETERINARY CARE TO THEIR PETS AND THUS RELIEVE THE ANGUISH AND ANXIETY OF THE HOMELESS WHO CANNOT PROVIDE FOR THEIR PETS.

PET FOOD, SUPPLIES, AND SLEEPING CRATES: NON-CASH AWARDS OF PET FOOD (126,644 LBS), PET SUPPLIES AND SLEEPING CRATES WERE DISTRIBUTED TO NON-PROFIT ORGANIZATIONS (MOSTLY FOOD BANKS) ACROSS THE COUNTRY TO ASSIST WITH THE FEEDING OF PETS BELONGING TO THE HOMELESS AND POOR. PET FOOD AND SUPPLIES THAT WERE PURCHASED BY POTW WERE GIVEN TO THE NON-PROFITS AND/OR DIRECTLY TO THE HOMELESS.

EMERGENCY VETERINARY CARE: IN 2019, THERE WAS 1,013 INVOICES TOTALING \$287,181 (AVERAGE OF \$283) PAID TO 206 HOSPITALS IN 24 STATES WITH A TOTAL OF 773 PETS TREATED, 90% WERE DOGS OF THE HOMELESS. HOSPITALS GAVE AT LEAST A 20% DISCOUNT. 60% OF THE CALLERS WERE WOMEN, 6% VETERANS. THE AVERAGE TIME THEY HAD BEEN HOMELESS WAS 2 YEARS AND 8 MONTHS. 32% WERE LIVING IN THEIR VEHICLES.

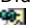
