THE 12-BED RESIDENCE PROVIDES A STRUCTURED RECOVERY PROGRAM WHERE WOMEN RECEIVE COUNSELING TO FOSTER INDEPENDENT LIVING, FIND EMPLOYMENT, FINANCIAL LITERACY, AND TO LIVE A HEALTHY LIFESTYLE THROUGH GOOD NUTRITION, EXERCISE AND DAILY LIVING HABITS. GHH IS A SUPPORTIVE PEER RECOVERY ENVIRONMENT BUILT ON EVIDENCE-BASED RECOVERY MODELS WHERE THE WOMEN REMAIN DRUG-FREE. RESIDENTS PARTICIPATE IN DAILY 12-STEP MEETINGS, WEEKLY GROUP RECOVERY MEETINGS AND VOLUNTEER IN PROGRAMS TO HELP OTHERS BY GIVING BACK TO THE COMMUNITY.
