ONE MISSION PROGRAMS MAKE LIVING IN THE HOSPITAL LESS LONELY AND STRESSFUL, BRING BACK JOY IN A TIME OF FEAR AND UNCERTAINTY, AND GIVE KIDS AND THEIR LOVED ONES THE SUPPORT THEY NEED TO GET THROUGH THE EMOTIONAL AND FINANCIAL CHALLENGES OF TREATMENT. ONE MISSION OFFERS OVER 30 VITAL PROGRAMS AND SERVICES, THE MAJORITY OF WHICH TAKE PLACE AT BOSTON CHILDREN'S HOSPITAL, THE JIMMY FUND CLINIC AT DANA-FARBER AND HASBRO CHILDREN'S HOSPITAL. IN 2019 ALONE, ONE MISSION ASSISTED OVER 1,000 NEW FAMILIES DURING THEIR BATTLES WITH PEDIATRIC CANCER. COOKING CLASSES AND BIRTHDAY AND SPECIAL OCCASION CELEBRATIONS ARE EXAMPLES OF PROGRAMS THAT ALLOW KIDS TO HAVE FUN AND JUST BE KIDS. CREATIVE THERAPIES: CREATIVE THERAPIES ARE DESIGNED TO LIFT THE SPIRITS OF PATIENTS, PROMOTE HEALING, AND PROVIDE AN OUTLET FOR EMOTIONAL EXPRESSION AND INCLUDE MUSIC, ART, AND STORYTELLING. PATIENT AND FAMILY SUPPORT PROGRAMS: THESE FAMILY-CENTERED CARE INITIATIVES PROVIDE COMFORT, ASSISTANCE AND SUPPORT TO PATIENTS AND THE FAMILIES WHO CARE SO DEEPLY FOR THEM.
