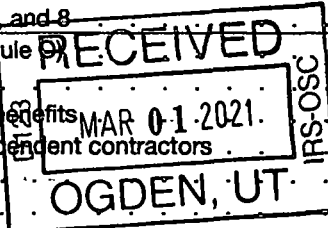

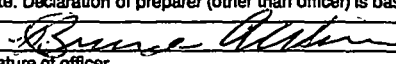

Each year we receive many calls, emails, and texts alerting us to potential environmental problems. We are very grateful to all those who keep alert and let us know when they see these potential problems. Some turn out to not really be a problem (dye testing of stormdrains, for example). Others turn out to be important issues (improper and illegal storage of milled pavement on the bank of a stream without proper erosion control).
