 K9 CARE MONTANA'S MISSION IS TO PROVIDE OUTDOOR ACTIVITIES FOR SPECIAL NEEDS CHILDREN AND THEIR FAMILIES. THE PROGRAM ENCOURAGES GROWTH AND A HEALTHY MIND IN A SAFE ENVIRONMENT AND SHOWS YOUNG AND OLD ALIKE THAT THERE IS HOPE AND FUN IN THE WORLD REGARDLESS OF THEIR DISABILITIES AND/OR OUTSIDE CHALLENGES. THROUGH EXERCISE, OUTDOOR ACTIVITIES, AND ONE-ON-ONE ATTENTION FROM EXPERIENCED INDIVIDUALS, K9 CARE PROVIDES MENTAL STIMULATION AND ENCOURAGEMENT TO THOSE WHO NEED IT DURING A DIFFICULT LIFE TRANSITION OR SITUATION.

**28** K9 Care Montana Inc. (K9CMT) continues to provide service dogs at no cost to wounded veterans and families challenged by autism. It takes up to 2 1/2 years to complete the training process in order to meet service dog status. Until then the dogs are considered as SDIT's, Service Dogs in Training. Throughout this lengthy process we are implementing therapeutic outdoor activities, which are geared towards the recovery and rehabilitation of the individual. Back country adventures, fly fishing, Gemming, and visiting historic Montana towns such as Philipsburg are some of the outdoor activities we offer at K9CMT. During such activities we are able to observe the recipient so we can customize their SDIT to better meet their needs. In 2019, we were presented with several opportunities to work a bit outside our usual box. Those opportunities came about, in part, as a consequence of a growing Montana awareness of who we are and what we do. We were players in a broader effort to get a bill to our governor's desk which made it illegal to put a service dog vest on a pet in order to gain public access. Governor Bullock signed HB 439 establishing that law. We were also asked to provide technical advice into the construction of an Airport Service Dog Relief Area at Bozeman's Yellowstone International Airport. We were happy to help. Lastly, under our AEGIS as a not for profit organization, we helped garner the resources and labor necessary to retrofit the home of one of our recipients who health has declined over the past few years. Relocation Complete: With limited resources and broad volunteer support, we are essentially setup and K9CMT is up and running at my home in Livingston. Throughout the summer we concentrated on our new kennels. They're heated and hot water is available, drinking and feeding utensils are upgraded, security fences for the kennels and an exercise area are in place, just to name a few of our completed tasks. The Circle Keeps Growing: We are happy to tell you that we are currently working with 76 recipient families. A few are still at the "foster puppy" stage, but most are fully trained service dogs or formal services dogs in training. I should note that this number of represents K9CMT provided dogs. We are also working with a number of veterans who have their own dogs that we have helped train to standard.
