THE NAMES OF THE FALLEN SERVICE MEMBERS ARE EMBROIDERED ONTO BLACK RIBBONS THAT DRAPE EACH FLAG. LEADING UP TO THE FLAGS, POSTERS ARE DISPLAYED WITH THE PHOTOGRAPH AND NAME OF EACH FALLEN MILITARY MEMBER WHOSE FLAGS ARE BEING HELD.
