THE HEALTHY HARVEST FOOD BANK PROVIDES SUPPLEMENTAL FOOD TO OVER 9,000 PEOPLE MONTHLY IN OUR SIX-COUNTY TERRITORY OF LANCASTER, NORTHUMBERLAND, RICHMOND, WESTMORELAND, MIDDLESEX AND ESSEX. HHFB CURRENTLY DISTRIBUTES OVER 2.3 MILLION POUNDS OF FOOD ANNUALLY TO OVER 25 PANTRIES AND MEAL SITES.
