The organization solicits funds from supporters statewide through special fund raising events, 3-4 annual direct mail appeals, and 2-4 online appeals each year. In 2019 we sent the following direct mail appeals: Lapsed Donors Appeal to 197 people, Spring Appeal to 3,633 people, Fall Appeal to 2,989 people, and Year-End Appeal to 3,785 people. Our supporter list, to which we send our fundraising appeals, is open to the general public, and we regularly recruit community members to the list through online activity and community outreach events. In addition, we engage in fundraising through events, our website, and individual meetings with supporters who are not related to the organization or its leadership. A total of 445 individuals donated in 2019. Because we are a fairly young organization and because we focus on engaging low - and middle-income community members, most of our donors do not give large gifts. However, our work to engage these community members through both volunteerism and fundraising has attracted large grants from a handful of foundation funders. As a result, the actual funds received from these foundations is large compared to the actual funds received from the hundreds of individuals who make gifts ranging from \$1 to \$500. Our governing body represents the broad interests of the public and represents a broad cross-section of Missouri citizens, including clergy, nonprofit employees, active and retired medical providers, business owners, and impacted consumers. Our board has diversity in age, race, religion, geography, and socio-economic status to ensure that the voices of Missouri's diverse public are represented. The services we provide to ensure that all Missourians are able to access health care are directly for the benefit of the general public, and we engage members of the general public as volunteers throughout the year. In 2019, more than 1,000 Missourians across the state volunteered with our organization.</p>
