In 2019, Blueprint 58 continued and expanded their regular programming which includes Community Building, Mentoring, For Mothers Only (FMO), Sports, and Personal Development programs. Blueprint 58 expanded this programming by adding two new community small groups to its Personal Development programming, creating a new partnership with Carver High School to reach students for FMO, and developing a Mentor Mom volunteer program for FMO. Last year, Blueprint 58 developed a girls small group and a Carver lunch and learn group. These new community groups were held once a month and discussed life topics including relationships, regulating emotions, life goals, and character development. Blueprints boys high school bible study continued on a weekly basis with 20 high school boys meeting for breakfast and bible study before school. Regular enrichment events were also offered for the boys high school bible study which included trips to Civil Rights historic sites, a summer beach trip, kickball games, and bonfires. Blueprint 58s young mothers support group (FMO) held 10 group meetings serving 10 young moms and 11 children. In 2019, FMO developed a Mentor Mom program to match young moms with mentors to aid them in their parenting journey. Two mentor moms were matched with students in 2019. Blueprint was able to connect multiple young moms with job opportunities and aided in their transition into these jobs by providing child care, interview attire, and transportation. Lastly, FMO facilitated the donation of a car to a long time member of FMO. Blueprint 58 aided this young mom with obtaining a license, registration costs and starting insurance costs, and taught her the basics of owning and maintaining a vehicle. In 2019, Blueprint 58s sports Program formed and coached a boys basketball team to play in a local league and ran its own flag football league in the spring. Blueprint 58s flag football league hosted 6 teams from organization in neighboring communities which included 60 players and 6 coaches. A cookout for the community provided by Blueprint 58 and local volunteer groups accompanied each game as well as a devotion led by Blueprint 58 staff, volunteers, and guest speakers. Some partnering organizations and sponsors for the flag football league include Summerhill community Ministries, Refuge Church, Redeemer Church, Atlanta Leadership Club, Accent Decor, Harland-Clark, and Atlanta AirBNBs. Blueprint 58s Mentoring Program matched 5 new mentor student pairs in 2019, held quarterly mentoring events for students and mentors hosted its first parent engagement event, and provided three ongoing training sessions for mentors. In 2019, Blueprint 58 also took 60 youth and teens from their programs and in the neighborhood to week-long overnight camp. Blueprint 58s Community Building programming hosted cookouts during flag football games, served 250 mentors, students, families, and neighbors at their annual Thanksgiving Community Dinner, provided backpacks and school supplies for 120 students and hosted a Back to School Bash, and provided monthly breakfast for teachers and staff at local schools. Blueprint 58 also partnered with Pride for Parents to provide Christmas gifts for 10 families, provided support and supplies through the year to the local elementary and high school, and offered a full college scholarship to one student. Lastly, in 2019, Blueprint 58 partnered with Lord Aeck Sargent, Pencor, and Third Lens Ministries to develop architectural and construction plans, put together construction lists and costs, and value Engineer plans for their upcoming community center. Blueprint 58 attended neighborhood meetings and meetings with local council members as well as hosted community listening sessions to hear community voices and better understand how their building can meet community needs. Blueprint 58 received variance and building approval from their neighborhood, the larger community unit, and the city of Atlanta.
