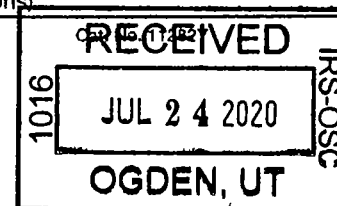

Committee meeting minutes and results of elections, voting, etc. are also preserved in accordance with the records retention policy.
