MEDIA & DEMOCRACY FILED LEGAL PETITION WITH THE FEDERAL COMMUNICATIONS COMMISSION ASKING THE AGENCY TO DENY THE PROPOSED \$26 BILLION MERGER OF T-MOBILE US INC AND SPRINT CORPORATION DERAILED THE SINCLAIR/TRIBUNE MERGER. IN JULY 2019, THE FCC REFERRED THE SINCLAIR/TRIBUNE MERGER FOR AN ADMINISTRATIVE HEARING. SHORTLY AFTER, SINCLAIR WITHDREW ITS MERGER FROM CONSIDERATION. WE PLAYED A MAJOR ROLE IN BLOCKING THE SINCLAIR-TRIBUNE MERGER THROUGH GRASSROOTS MOBILIZATION AND LEGAL ACTION. IF THE MERGER WAS APPROVED BY THE FCC, SINCLAIR WOULD HAVE REACHED OVER 70% OF HOUSEHOLDS, DROWNING OUT DIVERSE AND INDEPENDENT VOICES. IN EARLY JUNE WE ORGANIZED A RALLY OUTSIDE SINCLAIR'S SHAREHOLDERS MEETING THAT DREW A CROWD OF ACTIVISTS AND LOCAL REPORTERS. WE JOINED OUR ALLIES IN ORGANIZING A PETITION DELIVERY THAT GENERATED OVER 600,000 COMMENTS TO THE FCC OPPOSED TO THE MERGER. WE ALSO FILED MULTIPLE PETITIONS TO DENY OUTLINING THE LEGAL AND POLICY ARGUMENTS WHY THE FCC SHOULD BLOCK THE MERGER. OUR ACTIONS LED TO THE FCC REFERRING THE MERGER TO AN ADMINISTRATIVE HEARING, AND SINCLAIR EVENTUALLY WITHDRAWING. THIS IS A MAJOR VICTORY AND SHOWS THE POWER OF GRASSROOTS ACTIVISM TO FIGHT MEDIA CONSOLIDATION. FILED AMICUS BRIEF OPPOSED TO THE FCC'S NET NEUTRALITY REPEAL. IN AUGUST 2018, COMMON CAUSE FILED AN AMICUS BRIEF OUTLINING LEGAL AND POLICY ARGUMENTS OPPOSED TO THE FCC'S NET NEUTRALITY REPEAL. OUR AMICUS BRIEF WAS THE ONLY ONE IN THE RECORD TO FOCUS ON THE IMPACT OF THE LOSS OF NET NEUTRALITY ON OUR DEMOCRACY AND CIVIL RIGHTS. SEVERAL CIVIL RIGHTS ORGANIZATIONS SIGNED ON TO OUR BRIEF.
