IN 2019 WE STARTED A PARTNERSHIP WITH LOCAL MENTAL HEALTH PROFESSIONALS TO PROVIDE ONE-ON-ONE THERAPY TO RESIDENTS ON SITE. WE EXPANDED OUR CAPACITY WITH A NEW FULL-TIME AMERICORPS VISTA VOLUNTEER COORDINATOR TO FURTHER OUR COMMUNITY ENGAGEMENT. WE FUNDRAISED, DESIGNED, AND DEVELOPED NEW PARTNERSHIPS AND RELATIONSHIPS TO CREATE TWO NEW VILLAGES FOR 65 HOMELESS VETERANS, (IN PIERCE AND MASON RESPECTIVELY) AND WILL BEGIN CONSTRUCTION IN 2020.











