OUR MEAL PROGRAM IS A WAY FOR INDIVIDUALS, GROUPS, ORGANIZATIONS, AND EVEN LOCAL BUSINESSES TO PROVIDE A HOME-COOKED MEAL TO THE GUEST FAMILIES STAYING AT THE RONALD MCDONALD HOUSE OF THE GREATER HUDSON VALLEY. IN 2019 OUR CORE HOUSE PROGRAM PROVIDED 267 FAMILIES OVERNIGHT ACCOMMODATIONS WHILE THEIR CHILD RECEIVED MEDICAL TREATMENT AT LOCAL HOSPITALS. IN 2019 OUR VOLUNTEER MEAL PROGRAM SERVED 623 MEALS (16,430 PLATES) TO FAMILIES. IN 2019 OUR DAY PROGRAM PROVIDED RESPITE SERVICES TO AN ADDITIONAL 122 FAMILIES.
