ACADEMICS Through contemporary master's degree, doctoral degree, and graduate certificate programs, Erikson Institute prepares leaders in child development, social work, and early childhood education. We offer the most comprehensive, interdisciplinary understanding of children and families through classes on campus and online. In 2019, Erikson had the largest incoming class in its history with 168 new students, more than 400 students are enrolled across all our graduate education programs. We also offer programs to help professionals who work with children and families hone their skills, learn new techniques, and earn credits to maintain their professional licenses.

Research areas include early childhood math, social emotional learning, literacy, home based childcare, home visiting programs, and technology and media for children and families. Using evidenced-based research, Erikson's Early Childhood Leadership Academy provides early childhood and civic leaders with content knowledge to make the most informed decisions about policy setting and resource allocation. Participants have included some of the state's leading policymakers and community stakeholders, with over 100 alumni since its founding in 2016. Erikson's Community Data Initiatives help translate data for community planning, policy development, and early childhood resource allocation. In 2019, Erikson produced the Illinois Risk and Reach Report, which analyzes and translates data indicators in the areas of family stability, health and early care and education that affect the wellbeing of young children and how Illinois is allocating resources to mitigate "risk" factors undermining child development.
