Each year, parent mentors commit to participating in their child's school by volunteering 100 hours a semester, two hours a day, four days a week. The parent mentors are assigned to a classroom to work one-on-one and in small group settings with students. Parent mentors are active in instruction, skill development and reviewing key concepts with the children. Teachers and principals have expressed their strong support for the program because it has allowed for the additional teaching support in their classrooms to improve student success. The experience inside the classroom does not only impact the students, but is a transformative experience for parents. A majority of the parents participating in the Parents as Mentor program are stay-at-home mothers, many immigrant women, who move from isolation to involvement in the larger community.

Elev8:

The Elev8 Program at Marquette School of Excellence is a dynamic community school initiative with a goal to connect families with a variety of resources to help them thrive as community members. During the 2015-2016 school year, Elev8 offered over 30 different enrichment programs at Marquette, including Sculpture, Mikva Challenge, Sisters of Success, Drama Club, and Saturday programs for the whole family. SWOP has offered programming to over 1,100 participants in the past year. Additionally, SWOP has worked diligently with its partner Esperanza, Marquette's School Based Health Center provider, to make sure all students are medically compliant, by ensuring their physicals and immunizations are up to date.

Elev8 Marquette strives to improve student success by linking learning to real world experiences, while working closely with parents as advocates for reform and equity in

Healthcare-related organizing:

SWOP partners with Holy Cross Hospital and Esperanza Health Center to ensure community access to high-quality health care. In addition, SWOP recently completed a community-wide health plan detailing work to be done to improve the health outcomes of neighborhood residents. Activities include working to improve access and affordability of healthcare for the undocumented; working to increase and educate residents on how to navigate the health system so they can make the best choices for their families; working to promote the long-term viability of health institutions in the community; and working to promote access to health insurance. In the past, SWOP has assisted families in signing up for ACA and AllKids insurance.

Housing Issues:

Chicago Southwest is fortunate to have a solid, affordable housing stock, made up mostly of single family bungalows. For years, Chicago Southwest was targeted by sub-prime lenders who preyed on many first time homebuyers in the community. Even before the financial crisis of 2007-08, Chicago Southwest was suffering a foreclosure crisis. Working with Neighborhood Housing Services, Greater Southwest Development Corporation, and others, SWOP helped over 625 families keep their homes through our anti-foreclosure work. Unfortunately, many others could not be saved due to the high volume of foreclosures.

In 2013 there were nearly 700 vacant properties in the Reclaiming Southwest Chicago Target Area. SWOP and partner Brinshore Development are purchasing and rehabbing buildings which will then be rented or resold.

The SWOP/Brinshore Reclaiming Southwest Chicago effort seeks to acquire, rehab and reoccupy 100 vacant units within a 3-square mile target area. We have focused our efforts in and around the Chicago Lawn Micro Market Recovery Program (MMRP) area. Over the past three years our work has been responsible for reducing vacant properties in the MMRP from 80 units to 25. To date, SWOP has raised over \$11 million for the Reclaiming Southwest Chicago initiative.

Citizenship/civics workshops. The organizations's role was to 1) arrange location and grassroots publicity for workshops, 2) organize a team of leaders to volunteer at workshops, 3) provide leadership training to students in civics courses, and 4) link students to local area action initiatives.
