QUADRATIC VOTING - PILOT ON THE COLORADO STATE HOUSE:DURING Q1 AND Q2 2019 WE HAVE DEVELOPED THE FIRST IMPLEMENTATION OF QUADRATIC VOTING TECHNOLOGY FOR THE COLORADO STATE HOUSE. THIS ENABLED COLORADO LEGISLATORS TO PRIORITIZE 108 BILLS INTRODUCED TO CONGRESS COMPETING FOR A BUDGET OF \$120 MILLION BY USING A NOVEL GAME THEORETIC MODEL THAT ALLOWS VOTERS TO EXPRESS THEIR PREFERENCES AND THEINTENSITY OF THESE PREFERENCES.
