In 2018 the Board of Directors contracted with Propel Nonprofits for strategic consulting. One of their recommendations was to change the Executive Director position from a 0.50 FTE to a 0.75 FTE. Before finalizing the new ED position, the Board reviewed the Minnesota Council of Nonprofits salary survey.</p>
