In addition to dogs in training, OFP offers daycare and boarding at a no cost or reduced cost to First Responders, law enforcement K9s and OFP clients who need medical services where it is unsafe to take the dogs. To cover cost of staff OFP also offers daycare and boarding services to the public. The kennel facility is also used for training and a safe place for clients to come when in crisis. It also operates as a 24-hour hot line for all OFP clients.
