The Step Ahead program operates through a model of individual assistance and aims to take a comprehensive approach to ending poverty. Social workers, lawyers, psychologists, teachers and support staff work together to support 230 disadvantaged children. In 2019, this support includes \$19,452.23 for nutrition and health, \$69,974.92 for shelter, \$14,000 on case management, \$75,054.84 for Youth Development, \$50,600 for crisis care, \$811 for children with disabilities, and \$5,954 for other expense.

Stay in School is a program providing support to children in Bac Ninh Province at high risk of dropping out of school or who have recently quit due to poverty. There are 55 children in the program. Support includes school fees, bicycle and medical insurance.

Safe and Sound is an antitrafficking program in Hue and Dien Bien Provinces. In 2019, There are 292 victims who received benefits from the Safe & Sound program, including medical assistance, counselling, vocational training or assistance in returning to school.
