THROUGHOUT THE YEAR, OVER SEVENTY YOUTHS GRADUATED FROM MULTIPLE YOUTH DEVELOPMENT PROGRAMS, THROUGH WHICH THEY GAINED CRITICAL LIFE, JOB AND LEADERSHIP SKILLS, HEALTHY RELATIONSHIPS WITH FOOD, AND A SENSE OF SOCIAL RESPONSIBILITY.
