Lipstick Angels provides a clean-beauty and wellness program that restores dignity, hope, and self-esteem to cancer patients by offering personalized, oncology-sensitive beauty and skin care services in hospitals. In 2018, Lipstick Angels expanded services at City of Hope to include the Clinical Trials floor and expanded services at NewYork Presbyterian to include the David H. Koch Center. Lipstick Angels also launched new programs at Stanford Medical Center in the San Francisco region and Mount Sinai in the New York region. Lipstick Angels continued to serve the patients at NewYork Presbyterian Weill/Cornell, City of Hope infusion center, and the University of San Francisco Medical Center.
