The organization transforms vacant land into vibrant vegetable gardens, producing many different vegetables and fruits including collard greens, lettuce, tomatoes, spinach, herbs, green beans, radishes, carrots, arugula, squash, cucumbers, potatoes, watermelon, kale, onions, okra, eggplant, potatoes and more. It hires local residents to maintain the gardens, providing needed jobs. In 2019 the organization had ten (10) urbans farms throughout Southern Florida and distributed over 6,000 pounds of free fruits and vegetables to families in food deserts.
