Accomplishments in 2019 1. Multiple trips were taken to Africa (Uganda, Kenya, and Rwanda) by missionaries spanning the months of January/April/May/August/September, teaching and helping facilitate theology classes with our Trinity Biblical Institute, helping with in-country administration, preaching at churches and on our radio station WKTR, networking and planning for TBI with indigenous leaders. This is the heart and soul of our work 2. Hired a new seminary Principal, a Bursar, a Registrar and a Director of Quality. 3. Built a seminary campus with dorms, meeting hall, library, admin offices, basketball court and computer lab in Kapchorwa, Uganda on Mount Elgon in East Uganda. 4. Started work on the accreditation of Trinity Biblical Institute with the Ugandan National Council for Higher Education. 5. Implemented new donor management software with an online donation processor feature to cut costs and serve donors better. 6. Implemented new receipts software and modified our budget to cut expenses. 7. Raised approximately \$700,000 for theological education of pastors and missionaries in Africa. 8. Were approved by ten new churches for monthly missions support. 9. Added new staff Deputy Director and full time missionary. 10. Composed & wrote Bible Studies with guides for use by the Assistant Director in Africa. This included curriculum and for the teaching of courses for the certificate theology program. 11. Shipped a 40 foot container filled with 6,000 high quality theological and educational books to begin a library at the Ugandan seminary campus in Kapchorwa. 12. Presented at churches and social gatherings the mission and vision of Trinity Center of World Mission.
