Civic Saturdays: Civic Saturday is an event that gathers friends and strangers together to nurture a spirit of shared purpose. At these events, we connect around the values and practices of being an active citizen, reckon with and reflect on our nation's creed, and build relationships that create new civic traditions that are joyful and communal. We hold these events regularly in Seattle and partner with other organizations to produce them around the country in places ranging from Portland, Maine to Los Angeles, CA.

Youth Collaboratory: The Youth Collaboratory is a year-long program designed to empower and connect a rising generation of civic leaders and doers. 24 highly-motivated students from around the country join Citizen University and travel to cities around the nation 3 times during the year, meeting leading civic innovators, sharpening their literacy in citizen power, and ultimately producing their own independent projects in their communities. Youth Collaboratory sessions during this time period took place in Charlottesville, VA; Malibu, CA; and Washington DC.

Civic Seminary: The Civic Seminary is our training program held in Seattle where we teach leaders from around the country to build Civic Saturday events in their own communities. During this period, we trained 3 dozen leaders through this program.
