WPEs mission is to help end hunger and poverty in Contra Costa County by delivering the abundance all around us to those in need with love. Our Food Rescue Program rescues an average of 7,000+ pounds of high-quality, largely perishable, surplus fresh food every day from local grocers, retailers, farmers markets, restaurants, and wholesalers. It is then sorted and delivered by our team of volunteers and staff in refrigerated vehicles the same day to dozens of organizations serving those in need. The White Pony General Store Program (WPGS) distributes new and like-new clothing, shoes, toys, childrens books, and games free of charge to our Contra Costa neighbors in need.
