NorthBridge provides students with a multi layered support system that focuses on both academic success and personal development. The program includes individualized academic advisement, weekly academic support sessions, individual mentoring sessions, student success workshops, and coordinated social events. NorthBridge served 800 students through the 2018-19 program year. NorthBridge has now supported over 705 students in coaching and college retention. NorthBridge entered into a partnership with PhoenixUnion High School District and Valley of the Sun United Way, which resulted in a substantial increase in Accuplacer Ready enrollment. Through this partnership, NorthBridge was able to provide Accuplacer workshops to over 550 Phoenix Union High School students. The TechForceScholarship Ambassador Program showed dramatic results with improving retention among the 96 MMI UTI Ambassador students.
