The organization provided services to over 54,000 individuals regarding sexual assault, domestic violence, teen dating violence, sexual harassment and/or stalking in the 18-19 fiscal year. 13,900 men and women called the 24-hour Rape and Battering Hotline for crisis intervention, support and referral information. Counseling, case management, emergency response to victims and accompaniment of victims at hospitals, courts and law enforcement were provided to 28,448 individual. Additionally, over 11,900 men, women and youth participated in community, school or professional education and training in violence prevention strategies.
