recruited, highly trained volunteers teach a fun, interactive 12-week course using our

nationally recognized legal education curriculum, which covers relevant topics such as police

encounters, accomplice liability, three strikes, theft, vandalism, drugs, gangs, and police

arrests. The law curriculum is interesting and engaging to the youth, and is also an excellent

vehicle for us to teach critical life skills like anger management, problem solving, conflict

resolution, and resisting negative peer pressure. Everything is taught in a nonjudgmental

manner with no stigma is attached, which makes the youth more willing to learn. Mid-way

through the semester, youth take a field trip to a local university law school where they tour

the campus and act out a mock trial in the moot courtroom. The Law Program classes are taught

in schools, community centers, juvenile halls, and juvenile camps and ranches.

targets youth who are at moderate to high risk for justice system involvement and supports

and developing trust and teamwork skills. Youth then meet bi-monthly to support each other in

group settings and to design service learning projects in which they give back to the

community. Each leadership youth receives intensive coaching from a FLY case manager to

identify and address their greatest barriers to living a healthy, productive life.

Mentor Program pairs caring, trained adult volunteers with youth on probation for a year-long

mentoring relationship. Before they are matched with a youth, CAFA Mentors complete 26 hours

Once matched, Mentors build positive relationships with youth through weekly 1-on-1 meetings

and activities, helping them to develop new ambitions, set and achieve goals, and learn to
